# California Lightning Sprints Association

## Application for Annual Membership and Authorization for Publicity Usage

APPLICATION: I hereby apply for an annual membership in the California Lightning Sprints Association (CLS) of the type specified on this application. I certify that the information supplied by me on this application is true and correct and may be relied upon by CLS. I understand that a membership is subject to the Official Competition Rules of CLS. If my application is approved by CLS I agree to be bound by such Official Competition Rules and agree that decisions by CLS and/or interpretations of rules will be governed exclusively by the CLS board of directors.

CERTIFICATION: I certify that I am 16 years of age or older. I certify that I will assume all responsibility for all charges, premiums and taxes, if any, payable on any funds that I may receive as a result of my competitive activities, including without limitation, social security taxes, unemployment taxes, compensation insurance, income taxes and withholding taxes.

ACKNOWLEDGMENT: I hereby acknowledge and agree that I have no right, property or interest in any radio or television broadcast, motion pictures, still photographs, tape, or sound reproduction taken, made, transmitted, reproduced, or used for any purpose of any CLS sanctioned event, including practice, qualifications, the race, awards ceremonies or other event associated with the racing event, and also including but not limited to pictures and sound of me alone or with other persons with or without racing equipment, as well as any and all receipts there from, and any transcription thereof.

AUTHORIZATION FOR PUBLICITY USAGE: I agree that CLS, or its assigns, on a non-exclusive basis, may use my name and pictures of my racing equipment and pictures taken at any CLS sanctioned event for publicity purposes, but not for commercial sponsorship of any products.

### Annual Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement

In consideration of being granted an annual membership and/or competition license and in consideration of being permitted to enter for any purpose any "restricted area" therein defined as the entire racing facility including, but not limited to, the racing surface, pit areas, infield, garage areas, parking areas, and all walkways, roadways, concession areas appurtenant to any area where any activity related to the competitive racing event shall take place.

RELEASE AND WAIVER OF LIABILITY: I, for myself, my heirs, next of kin, personal representatives and assigns, hereby release, waiver, discharge and covenant not to sue the California Lightning Sprints Association (CLS), its successors and assigns, the race organizers presenting CLS-sanctioned events, the owners and lessees of premises on which CLS-sanctioned events take place, the participants in CLS-sanctioned events, (including car owners, drivers, mechanics, pit crews, and any persons in any restricted area), promoters, sponsors, advertisers, manufacturers of all racing equipment in any restricted area, and the officers, directors, officials, representatives, agents and employees of all of them (all of whom for the purposes herein are referred to as "releasees") from all liability, loss, demands, causes of action, court costs, attorneys fees and other expenses that may otherwise accrue from any loss, damage or injury (including death) to my person or property in any way resulting from, or arising in connection with, or related to, any CLS-sanctioned event, and whether arising while engaged in competition or in practice or preparation therefore, or while upon, entering or departing from any restricted area, from any cause whatsoever including without limitation, any failure to enforce rules and regulations, any failure to make inspections, or any negligence on the part of the releasees or any other persons.

ASSUMPTION OF RISK: I know that there is danger to myself and property, both from known risks and unanticipated risks, while I am in any restricted area or while I am attending, participation in, or assisting in a CLS-sanctioned event. I assume all such risks of loss, damage or injury (including death) to myself and my property from any cause whatsoever and whether or not attributable to the negligence of the releasees or any other persons. I assume all such risks willingly, voluntarily and in reliance upon my own judgment and ability, and not in reliance upon the property, equipment, facilities or services furnished by others.

INDEMNITY AGREEMENT: I hereby agree to indemnify and hold harmless the releasees and each of them from any loss liability, damage or cost they may incur due to the presence of the undersigned in or upon the restricted area, whether caused by the negligence or the releasees or otherwise.
